## **MAKO CHAMBER CONFERENCE**

CCEKS and the MAKO Chamber Conference are offering three scholarships (registration only) for the upcoming 2019 conference for chamber professionals in Kansas.

Two scholarships will be awarded to first-time attendees only. One scholarship is open to any member whether first-time or has attended MAKO in the past. Scholarship recipients will be selected based on the below criteria and completed application.

### **Application & Selection Criteria:**

1. Applicant must be employed as paid staff at a chamber of commerce located in Kansas (Volunteer leaders will not be considered).
2. Applicant or chamber must be **current member in good standing** with CCEKS.
3. Applicant is a first-time attendee (2 scholarships will be awarded).
4. Applicant can demonstrate a financial need to be considered for a scholarship.
5. Applicant must demonstrate a sense of professionalism and high-level of job performance.
6. Ability and willingness to pay remaining costs of the conference, i.e. travel, accommodations, meals not provided by MAKO, etc.
7. Applicant has not accepted a scholarship from other sources.
8. If awarded, applicant agrees that in the event they cannot attend, cancellation must be given to Ruth Littlefield by Friday, March 29, 2019. If the applicant does not cancel by this date, the applicant agrees that their employing chamber will be responsible for the full scholarship amount (\$295). This scholarship is non-transferrable.
